

**Ordinance No. 5/2015
of 29 January 2015
of the Rector of Medical University of Gdańsk**

**on charging tuition fees from students who wish to commence studies
at the Medical University of Gdańsk
in the academic year 2015/2016**

Pursuant to art. 99 item 2 of an Act on Higher Education of July 27, 2005 (Law Gazette of 2012, pos. 572 as amended) and § 17 of the Regulation of the Minister of Science and Higher Education on commencing study, participation in trainings, research and development by foreign students (Law Gazette of 2006, no. 190, pos. 1406, as amended)

It is hereby ordered:

§1

I. The University tuition fees charged for the studies commenced at the Medical University of Gdańsk in the academic year 2015/2016 shall be as follows:

1. Part-time studies (evening course)

a) Uniform master's studies

- ✓ Medical faculty PLN 13,000.00 /one semester
- ✓ Dental Faculty PLN 15,000.00 /one semester
- ✓ Pharmacy PLN 8,000.00 /one semester
- ✓ Medical Diagnostics PLN 8,000.00 /one semester

Faculties of Pharmacy and Medical Diagnostics in the academic year 2015/2016 are conditional on the enrollment outcome, which is the multiple of the Dean's group size.

First cycle Programmes

- ✓ Dental technology PLN 4,000.00 /one semester

2. Part-time studies (extramural course)

a) first cycle programmes (undergraduate studies)

- ✓ Dietetics PLN 3,000.00 /one semester

b) second cycle studies (graduate studies)

- ✓ Public health PLN 2,500.00 /one semester
- ✓ Physiotherapy PLN 4,000.00 /one semester
- ✓ Nursing PLN 2,700.00 /one semester

Part-time graduate Nursing studies in the academic year 2015/2016 are conditional on the enrollment outcome, which is at least 40 students.

3. Uniform master's studies in Polish language for foreigners

Entry fee PLN 1,000.00 (one-time registration fee)
 Tuition fee PLN 15,000.00 /one semester

4. Undergraduate and graduate studies in Polish language for foreigners

Entry fee PLN 1,000.00 (one-time registration fee)
 Tuition fee PLN 6,000.00 /one semester

5. Postgraduate studies (doctoral studies) in Polish language for foreigners

Entry fee PLN 1,000.00 (one-time registration fee)
 Tuition fee PLN 20,000.00 /one semester

6. Studies at English Division: medicine at Medical Faculty, pharmacy at the Faculty of Pharmacy and nursing at the Department of Health Sciences in PLN

7. Foreigners who comply with the conditions stipulated in art. 5 items 1-3 of an Act of November 9, 2000 r. on repatriation (Law Gazette of 2004, no. 53, pos. 532, as amended), who need to pay for their admission to studies and participation in courses and trainings conducted in Polish language, pursuant to § 1 sec. 1 of the Regulation of the Minister of Science and Higher Education on foreign students and conditions of their participation in studies, courses, research and development (Law Gazette of 2006, no. 190, pos. 1406, as amended) are eligible for 30% discount.

8. In justified and well-documented cases tuition fee per one semester may be paid in two (2) equal installments, 50% of the total fee each. An appropriate Dean may take a decision to divide the payment of tuition fee into instalments.

9. Additional payments charged for :

- 1) repeated year
amount to annual tuition fee for part-time studies at a given faculty as stipulated in Study Rules and Regulations

- 2) academic probation
amount to tuition fee charged for a repeated subject only, as stipulated in Study Rules and Regulations

with the exception of the following programmes: radiography (bachelor's degree), physiotherapy (bachelor's degree), nursing (bachelor's degree), midwifery (both bachelor's and master's degree programmes), emergency medicine (bachelor's degree), public health (bachelor's degree), environmental health (bachelor's degree), for which additional payments amount to **PLN 5,000.00**.

All additional payments for dietetics, in both situations as above (master's degree programmes) amount to **PLN 8,000.00** for each academic year. The charges cover all the expenses related to the repetition of the year and academic probation.

3) Making up for curriculum differences :

students studying at Polish language programmes	PLN 300.00	for each subject
