Ordinance No. 15/2016 of 15 April 2016 of the Rector of Medical University of Gdańsk

on charging tuition fees from students who wish to commence studies at the Medical University of Gdańsk in the academic year 2016/2017

Pursuant to art. 99 item 2 of an Act on Higher Education of July 27, 2005 (Law Gazette of 2012, pos. 572 as amended) and § 17 of the Regulation of the Minister of Science and Higher Education on commencing study, participation in trainings, research and development by foreign students (Law Gazette of 2006, no. 190, pos. 1406, as amended) and § 31, sec. 4 of the Medical University of Gdańsk Statuses of June 08, 2006 (i.e. Annex no. 1 to the Resolution no. 8/2015 of the MUG Senate of March 30, 2015 as amended)

it is hereby ordered:

§1

I. The University tuition fees charged for the studies commenced at the Medical University of Gdańsk in the academic year 2016 /2017 shall be as follows:

- 7. In justified and well-documented cases tuition fee per one semester may be paid in two (2) equal installments, 50% of the total fee each. An appropriate Dean may take a decision to divide the payment of tuition fee into instalments.
- 8. Additional payments charged for:
 - repeated year amount to annual tuition fee for part-time studies at a given faculty as stipulated in Study Rules and Regulations

^{***} Preparation course at the Faculty of Health Sciences are conditional on the enrollment outcome, which is at least 10 students

 academic probation amount to tuition fee charged for a repeated subject only, as stipulated in Study Rules and Regulations

with the exception of the following programmes: radiography (bachelor's degree), physiotherapy (bachelor's degree), nursing (bachelor's degree), midwifery (both bachelor's and master's degree programmes), emergency medicine (bachelor's degree), public health (bachelor's degree), environmental health (bachelor's degree), for which additional payments amount to **PLN 5,000.00.**

All additional payments for dietetics, in both situations as above (master's degree programmes) amount to **PLN 8,000.00** for each academic year. The charges cover all the expenses related to the repetition of the year and academic probation.
